LEGISLATION NWT/ NU	PUBLIC PRACTICE	FINANCE
<p>The Chartered Professional Accountants Act (the Bills) were introduced into both the NWT and NU Legislative Assemblies in the Spring Sessions. The Bills, which are consistent in both Territories received first and second reading during the sessions and were subsequently referred to the respective committees for review. The TSC has submitted comments and support to the Standing Committees requests in both jurisdictions. Once the Standing Committees have completed their review we expect the Bills to proceed to third and final reading, at which time a coming into effect date will be decided to coincide with the adoption and implementation of supporting by-laws facilitating the transition from the legacy bodies to the new Chartered Professional Accountants Act.</p>	<p>The Public Practice committee would like to advise members that the committee has been working diligently to prepare the CPA NWT/NU rules for Public Practice. This includes preparing the forms and applications to support entrance requirements for legacy members into Public Practice. The Public Practice Policy is being prepared to ensure all new CPA requirements are included. 

## MEMBER PROFILE

We would like to introduce **William Graham, CPA, CMA** as our first member profile.

### **CPA NWT/NU: Where were you born?**

I was born in England in 1943, came to Canada in 1946 and grew up in Toronto.

### **CPA NWT/NU: When did you receive your legacy accounting designation?**

I received my Certified Management Accountant designation in 1985 and went on to receive my Fellowship in 2002.

### **CPA NWT/NU: When did you receive your legacy accounting designation?**

### **CPA NWT/NU: Can you tell us about your work history?**

Prior to 1973: Canadian Pacific Railway and the Canadian Armed Forces, Signal Corp.

1973 The Canadian Penitentiary Service in Ontario and Saskatchewan, working my from an accounting clerk to Assistant Director of Finance.

1978-82 Northern Affairs Program, Indian and Northern Affairs Canada, Yellowknife, NWT, Director Finance and Administration responsible for administration, finance, material management, air operations and library services. In 1982 I was seconded to the Assistant Deputy Minister NAP (Hull, PQ) to develop and establish a Program Support Division. Following this, I started working for the Government of the Northwest Territories.

1982-83 Senior Finance Officer, Public Works and Highways, YK

1983-87 Director of Finance, Economic Development and Tourism, YK

1987-89 Regional Superintendent, Keewatin Economic Development and Tourism, Rankin Inlet

1989-95 Seconded to a group of privately owned Inuit companies in the Keewatin as Chief Executive Officer

1995-96 Utilized accumulated leave credits prior to retirement with 28 years (Canadian Army, Governments of Canada and Northwest Territories and concurrently doing private consulting.

I joined the private sector in 1995. I was also an instructor in the Management Studies Program at Aurora College for the years 1999-2003. I fully retired in 2012.

### **CPA NWT/NU: Were you active with the CMA Organization during this time?**

I was President (twice), vice president, secretary-treasurer (twice) director at large and executive director (5 or 6 years). Recently, working with others, completed the final draft of the by-laws for CPA NWT/NU.

### **CPA NWT/NU: Tell us about any activities you were or are involved in?**

I became engaged in sports after moving to Yellowknife. I played recreational softball and became a 5 pin bowler. I became a certified umpire for slo-pitch and fast pitch (achieved level 3), a certified coach in 5 pin bowling and softball. In 2018, I completed introductory coaching course for Special Olympics. On a national level, I coached the Yellowknife youth bowlers at the 1983 National Youth Bowling Championship and the men's team at the 1983 Canada Winter Games.

I was also a member of the Mission staff at the 1993 Canada Summer Games

I was team manager Special Olympics National Summer Games in 2014. For the 2018 Special Olympics Nationals, I will be the mission staff and team manager. I have participated in three previous 55+ Canada Games as a duplicate bridge player and will participate in 2018 in swimming the 75-79 age group.

Current passions are swimming several times a week, working out on the stationary bicycle and doing light weights.

Over the years I have sat on a number of volunteer boards; the Stanton Hospital Foundation, St. John Ambulance, Northwest Territories Network-Canada Volunteerism Initiative, Special Olympics, and Yellowknife Seniors Society. Current volunteer activities are participating in the Special Olympics bowling and swimming programs and ad hoc requests for assistance from various groups such as Council for Disabilities and Yellowknife Seniors Society.

Since I fully retired, my partner Carole and I do a lot of traveling especially cruising. Two continents left to go; Asia and Antarctica. I am enjoying life.
